

NOTICE FOR OPEN ENROLLMENT

Open Enrollment begins April 2, 2024, for all retirees under the age of sixty-five (65) who wish to enroll or make changes in the Town's insurance plans. In addition to dental the Town is offering **Blue 2020 Vision Insurance** to all retirees. If you are over 65 and on Medex, this open enrollment is for dental and vision only. All forms should be returned to Human Resources by May 10, 2024. **If you do not wish to make any changes, then your coverage will remain the same.**

If you plan to enroll in the health, dental or vision plan, we encourage you to attend the Benefit Fair on April 2, 2024, at the Council on Aging from 2:00p.m. to 5:30p.m. and complete the appropriate enrollment forms. If you're unable to attend, the forms can be found on the Town website or email Eileen with your request.

Due to the rise in claims experience and prescription drug costs this year, the health insurance premiums will increase by 3.8%. Although an increase is not ideal, overall Rockland premiums continue to remain very competitive. The Town has increased the annual dental allotment from \$1350 to \$2000 to assist employees and retirees with the higher out of pocket dental costs which will in turn increase the dental premiums. Please see the chart below for the new pricing effective July 1, 2024.
